- From sale of each burial space, monies are invested in an Endowment Care Fund.
- Certificate of Ownership of Burial Rights (Deed) will be issued only when payment in full is received.
- The ownership and subsequent use of all grave spaces, shall, at all times, be subject to all of the Church Canons, laws and discipline of the Roman Catholic Church, of the Archdiocese of Milwaukee and of the above listed Parish Cemetery now in force or hereafter duly enacted.
- No memorial may be placed at any grave unless paid in full; memorials are subject to the privileges and restrictions in force at the above Parish Cemetery, so consult with Management before placing a memorial. The memorial is the responsibility of the family or purchaser.
- Compliance with the Rules & Regulations, especially Decoration Regulations, of the above Parish Cemetery is required. Violations of the Decoration Regulations will be removed without notice.
- Married couples have joint tenancy and both exercise ownership rights.
- The cost of burial is a separate fee not included in the cost of the space.
- This is not a sale of real estate, but of burial rights within a cemetery that is continuously owed and operated by the above parish.
- Seller may terminate this agreement and return any money paid for non-payment or non-performance; Purchaser may terminate within three days without cause or penalty.
